- Firm should be registered as a firm for more than 10 Yrs.
- The Firm should have completed Turnkey Interior works for atleast one office building with project value not less than Rs. 4.00 crores in the past 10 years.
- The bidders should have average annual turnover not less than **Rs. 400 lacs** during last three years, starting from April 2013. This evidence must be shown by the bidders in technical proposals supported with audited financial statements/balance sheet.
